Participating in LifeWave®

As a LifeWave Brand Partner, you can participate by:

Cost to Register and Renew

You do not need to purchase products to become or remain a LifeWave Brand Partner. The enrollment fee is \$25, with an annual renewal fee of \$25.

Direct Selling as a Brand Partner

The LifeWave opportunity is based on product sales. As a LifeWave Brand Partner, you cannot earn commissions by merely sponsoring or recruiting others. You can earn by:

- Applying retail markup on LifeWave products you sell to customers
- Earning sales commissions based on your product sales and the product sales of LifeWave Brand Partners in your sales organization.

Your success in the LifeWave sales opportunity will vary. Many factors are involved, including your customer base, networking skills, business experience, effort, persistence, and the quality and extent of your sales organization.

Your Earnings

21% of registered and active LifeWave Brand Partners received a commission payment from LifeWave in at least one month of 2024 for sales that occurred in 2024. The expenses a LifeWave Brand Partner incurs in the operation of his or her LifeWave business vary widely. Expenses for Brand Partners can be several hundred or thousand dollars annually.
